Help campers build friendships, have fun, and grow spiritually. 3) Maintain a wholesome and caring community. 4) Assist in overseeing campers by sight and sound and make appropriate judgments in responding to various needs or emergencies. 5) Always follow the safety rule of truddie's - which is "three buddies" – always at least one adult with two campers or at least two adults with one camper. 6) Perform all duties required for the position and as a camp team member 8) Full participation in required Volunteer Training prior to camp.
